- 4. You are excluded from meetings or have a reduced role
- 5. Someone is pointing the finger
- 6. Client retains a third party consultant to review your work or services
- 7. You have an overall unsettled feeling
- 8. Someone has told you that you're going to be sued or named in a complaint
- 9. You have received a subpoena for documents or deposition testimony
- 10. Disciplinary proceedings have commenced against you or your firm
